Personally, all past presidents have two additional years of board responsibility; organizing the Summer Strategic Planning meeting and chairing the Nominating Committee. As a community orthopaedic traumatologist, I intend to concentrate on our home program in Reno and devote more time to the continued development of our new fellowship. Hopefully, our orthopaedic trauma 'business curriculum' will grow into an educational standard shared by all OTA approved programs.

In closing, your organization is a forward thinking group of talented surgeons; your OTA future will continue to be bright and productive. As I mentioned in my Presidential Address, "It is an honor to recognize all of you gifted physicians who have the incredible privilege of getting up at night.... to do the right thing."

#### **RESEARCH COMMITTEE** *Edward Harvey, MD*

The OTA research committee has had another busy year. There have been an increasing number of excellent projects submitted over the year in all categories. The resident grant proposals are accepted bi-annually with an amazing 62 grant proposals being tendered this year. Thirteen have been funded so far. We hope to fund 10-12 more resident grants in the second evaluation process. The call for full OTA member grant proposals was answered loudly; as 47 applications were made. Twenty-nine of these research teams were asked to write a full proposal after review of the applications by the committee. Funding of the 8 successful grants resulted in 75% of the research money being directed to clinical research projects with the other 25% going into more basic research topics.

The committee itself has expanded to ensure an adequate review process for all concerned. The rules of application have been streamlined as well as the process itself as we have now gone online with all applications. The team leadership is also transitioning - with **Ed Harvey** stepping down as chair in February and **Todd McKinley** stepping up to the role of leader of the Research Committee. With other important additions, this hard working committee is now made up of a truly diverse group of clinical scientists with interests in all aspects of trauma care and research.

Kudos to Donald D. Anderson, PhD, J. Lawrence (Larry) Marsh, MD and Thomas D. Brown, PhD, who were selected to receive the prestigious OREF 2011 Clinical Research Award. The award paper entitled "The Pathomechanical Etiology of Posttraumatic Osteoarthritis Following Intra-articular Fractures," was presented by Dr. Anderson at the Annual Meeting of the Orthopaedic Research Society in January 2011, and will be recognized at the February 2011 Annual Meeting of the American Academy of Orthopaedic Surgeons. Dr. Anderson noted that his 2005 OTA Research Grant entitled "Objective Assessment of Injury Severity in Complex Intra-Articular Fractures" was instrumental in advancing this line of research. The research grant was funded by OTA and Smith & Nephew.



#### **Bylaws Committee** Lawrence Webb, MD (Chair), Alexandra Schwartz, MD and Mark Anders, MD

There are **2 amendments scheduled to come before membership at the upcoming OTA Business Meeting**. Finalized wording will be sent to the OTA Membership and posted on the OTA Website soon (at least 10 days prior to the OTA Business Meeting).

The first proposed amendment is to create a path for Orthopaedic Trauma Fellows to become members of the organization. This entails expanding the Candidate Membership category to allow Fellows to apply for membership for up to 18 months after completing a fellowship. Candidate Membership requirements will also be amended to require participation in an American or Canadian residency or fellowship program.

A second proposed amendment that will be presented for a membership vote is the elimination of the publication requirement for Active Membership, thus expanding the Active Membership category to include current Community members as voting members. Simultaneous establishment of an "active eligible" status for active members who fulfill the current publication requirement will be included in the proposed bylaws amendment. Only "active eligible" members will be eligible to serve in elected governance positions, and/or as committee chairs.

The meeting was well attended and had several distinguished keynote speakers, including : The Honorable Tim Walz, US Congressman, (DFL-MN) ; The Honorable Jason Altmire, US Congressman, (D-PA) ; and MAJ L. Tammy Duckworth, Assistant Secretary of Public and Intergovermental Affairs, Dept. of Veterans Affairs. EWI continues to promote the collaboration of military and civilian orthopaedic surgeons and researchers to advance the care of the wounded warrior.

#### **SLEEP DEPRIVATION IN SURGEONS**

The *New England Journal of Medicine* published an editorial in its December 30, 2010 issue on sleep deprivation by physicians from three medical institutions and has called for patients' informed, written consent whenever a surgeon is sleep deprived prior to performing elective surgical procedures. As you can imagine there have been numerous thoughts and debates on this issue. **Dr. Andrew Pollak** provided feedback in an *Orthopaedic Today* issue, with his comments:

The OTA shares the concern of others about the potential for sleep deprivation, both acute and chronic, to have a negative impact on quality of surgical care.

We believe surgeons should take steps where possible to avoid situations where need to perform elective surgery CONTINUED ON PAGE 6

*in the context of sleep deprivation is likely. We also believe that surgeons should disclose sleep deprivation to their patients if surgical intervention is planned.* 

We do not believe that governmental regulation in this area is in patients' interest. We believe such regulation has a higher likelihood, particularly in smaller communities, of limiting access to emergency services than it does of ensuring quality of care."

#### **METRC** Lisa Reider, MHS Johns Hopkins School of Public Health

The Major Extremity Trauma Research Consortium (METRC) was established in September of 2009 with funding from the Department of Defense (DOD). It consists of a network of clinical centers and one data-coordinating center that will work together with the DOD to conduct multi-center clinical research studies relevant to the treatment and outcomes of orthopaedic trauma sustained in the military. The overall goal of the Consortium is to produce the evidence needed to establish treatment guidelines for the optimal care of the wounded warrior and ultimately improve the clinical, functional and quality of life outcomes of both service members and civilians who sustain high energy trauma to the extremities.

METRC is a collaboration of 24 Core Civilian Trauma Centers, 4 Military Treatment Facilities, and 38 Satellite Centers throughout the United States, unified to identify and address critical issues challenging the recovery of combat and civilian trauma patients. Members of the Canadian Orthopaedic Trauma Society also participate as satellite centers. Check out the website: www.METRC.org.

The Major Extremity Trauma Research Consortium is funded through cooperative agreements with the United States Army Institute of Surgical Research (USAISR) Orthopaedic Extremity Trauma Research Program (OETRP) (Award # W81XWH-09-2-0108) and the DOD Peer Reviewed Orthopaedic Research Program (PRORP) of the Congressionally Directed Medical Research Program (CDMRP) (Award # W81XWH-10-2-0090).
