PRESIDENTS CORNER Jeffrey Anglen, MD

It was a great thrill for me to accept the gavel from Mike Bosse on board the USS Midway during our OTA member's reception after Specialty Day in San Diego. As daunting as it is to follow two great Presidents like Mike and Paul Tornetta, I am encouraged by their continued involvement and support, as well as the talents and enthusiasm of the two Presidentelects, Tracy Watson and Dave Templeman. They truly form an "all star" team which will make my job easy. The success and respect that OTA has in the orthopaedic community is due to the many great leaders we have as committee chairs and members, our tremendous staff, and the talents and energy of our members. Membership Chair Dave Karges reports that our membership has increased to over 800, including 84 members on active duty military service, 369 Active Members, 49 Associate Members, 126 Community Members, 70 International Members and 127 Candidate Members and 9 Research Members.

I want to let you know about some of our ongoing projects and successes. The education committee, lead by Mike Baumgaertner, continues to produce courses and content that are the envy of other specialty societies. The Advanced Trauma Techniques Course for Residents was last month in Chicago (see inside for exciting details). This course, along with the Fall Comprehensive Fracture Course for Residents, directed by Kevin Pugh and Steven Morgan and the Resident Lecture Series (available on the OTA website), chaired by David Teague, have established OTA as a premier provider of resident education. The Comprehensive Trauma Course produced in partnership with the AAOS has just completed another great run. Thanks to all the volunteers who served as faculty for courses and authors for publication projects - the extremely high quality of your work has made OTA the "go to" source for ortho trauma educational content.

Our research fund continues to grow under the stewardship of CFO Alan Jones, thanks to the many members who donate each year and to our corporate partners. Last year, as you know, we began a new, somewhat experimental program with OREF. Donors to the OREF at the "Order of Merit " level (\$1000) have always been able to designate 50% of their donation to go to a specialty society. In the new program, thanks to the initiative and leadership of Michael J. Bosse working with the OREF, new donors at lower levels will be able to designate to OTA a portion (40%) of their donation. Our goal is to build to 100% participation of the society. The members of the OTA Board and the committee chairs kicked off the campaign by personally pledging \$1000 apiece. Despite a late start in 2006 with this campaign, the result doubled participation of OTA members as OREF donors. Thanks to all who contributed. If you didn't get to it last year, join us this year. The link to contribute is found under the Research heading on the OTA website www.ota.org.

Joseph Borrelli and the Research Committee are charged with using those funds raised to advance our knowledge, and they have recruited and funded a record number of high quality projects. Over a half million dollars of research funding was awarded to OTA members during the last cycle, a dramatic increase from previous years. This increase has been driven by multi-year clinical projects, directed topic grants, and an expansion of the resident project grant program. With the assistance of Basic Science Chair Ted Miclau, the research committee has worked to teach OTA members to write competitive grant proposals, identify areas of needed research, and develop multicenter projects.

William Creevy was appointed the first chair of the new Practice Management Committee, split off from Coding and Classifications led by Larry Marsh. The charge of that committee is to help manage the critical RUC process for updating RVU values for trauma CPT codes, guide input in the CPT process, and develop practice management education or other programs for orthopaedic trauma practices. Mitch Harris has taken the Health Policy baton from Jim Nepola, and is directing OTA's advocacy efforts on multiple fronts. David Teague is leading the group of OTA members on the American College of Surgeons Committee on Trauma. Craig S. Roberts and the PR committee (Jeff Smith and Peter Nowotarski) have produced an office brochure and an Emergency Department pelvic fracture poster for distribution by members to referring EDs. Andy Schmidt and the Program Committee are currently reviewing a record number of submitted abstracts for the fall Annual Meeting in Boston. Make your plans now to attend.

With all this activity, there is no shortage of opportunities to be involved with your specialty society. In addition, we have begun to explore a role for OTA in orthopaedic trauma education and care in the developing world. Collaboration with Lew Zirkle's SIGN organization was approved by the Board which will provide OTA educational material and opportunities to orthopaedic surgeons dealing with trauma in disadvantaged parts of the world. We are also looking for volunteers to be involved in the AAOS' international courses and with their Africa Cooperative Education Program (ACE), which is developing an orthopaedic course for health care professionals in West Africa. Additionally, OTA will partner with AAOS to co-brand an educational program in Kuala Lumpar, Malaysia in 2008 with David Templeman as Course Director.

This is indeed an exciting time for OTA. Thanks to all who have volunteered, and all who will in the coming year. Please let me know if you have any questions, comments, or suggestions.

AAOS/OTA SPECIALITY DAY Lisa K. Cannada, MD

Specialty Day, under the direction of Dr. Michael J. Bosse and the Specialty Day Planning Committee was a huge success. There were more than 600 attendees for the program "Outside of the Box: Non Academic Medical Center Trauma".

The day began with lively discussions from Timothy J. Bray, Roy Sanders, Jeffrey M. Smith and J. Andrew Trenholm on different trauma practices in the non-university environment. Next was Daniel S. Horwitz's session on medical malpractice issues in which he presented some interesting cases. There were also lectures on locked plating including one to answer the often asked problem: "Help-I can't get my locked plate out".

The annual meeting highlight papers followed. There are always good questions raised by the papers and these presentations were no exception.

The afternoon session included Femoral Nailing Tips and several lectures on reduction tactics for long bone stabilization. Great technical advice was given and a chance for all attendees to learn from the experts and their experiences (including the mistakes). Obesity is a (growing) problem in America, and trauma patients are no exception. There are multiple considerations in the treatment of the obese trauma patient including radiology issues and soft tissue considerations in addition to the obvious.

Fracture healing is always a hot topic and the discussion included BMP's, electrical stimulation and ultrasound. The hype surrounding these products can be mind-boggling and it's always good to have some objective information.

The day concluded with a session on "Critical On-Call Issues: Making It Through the Night." Great tips on dealing with pelvic fractures, Damage Control Orthopaedics, Pediatric issues and Limb Threatening Lower Extremity Complications were addressed. Our 2006-7 President, Michael J. Bosse, MD concluded with an interesting lecture on "When to Get Level 1 Support."

The OTA member reception was on the USS Midway. The evening included a tour of the ship, the San Diego Aircraft Carrier Museum aboard the USS Midway and flight simulator games to keep everyone entertained. The food was great and the company even better. During the reception, Dr. Bosse handed over the Presidential medal to Jeffrey O. Anglen, MD.

The next Advanced Trauma Techniques Course is scheduled to take place May 16 - 17, 2008 in Dallas, Texas.

KATHRYN CRAMER MEMORIAL AWARD Heather A. Vallier, MD

AO North America has established an annual award in memory of Dr. Kathryn Cramer, to honor her contributions to orthopaedic trauma patient care and education. The award promotes educational and research endeavors to foster the development of orthopaedic surgery residents and fellows pursuing careers in orthopaedic traumatology, or orthopaedic traumatologists in their first two years of practice. Funding may be used for research projects or travel for educational reasons. Requests for up to \$15,000 for one year will be considered.

Dr. Christopher McAndrew, a resident in orthopedic surgery at Case School of Medicine, was the recipient of the first annual Kathryn Cramer Memorial Award. Dr. McAndrew received \$15,000 for his project entitled "Timing and Method of Analgesia and Anesthesia for the Reduction of Pediatric Forearm Fractures. A Prospective Randomized Study of Three Treatment Protocols." his was one of many excellent proposals that were reviewed by the award committee. Dr. Cramer was a pioneer in the field of orthopaedic traumatology, with a special interest in fractures in children. This research project will help to continue her legacy.

OREF: WORKING TO KEEP EXPENSES LOW Gene Wurth, OREF President and CEO

At OREF, we work hard to keep both our operational and fundraising expenses as low as possible while still maintaining growth in our program. Our goal is to provide adequate funding for current research and education efforts while building a substantial endowment to fund future research for many years ahead. Our efforts are allocated in those two directions – current needs and future permanent support.

We also work to raise money for OREF itself and for more than 30 related orthopaedic organizations – our "orthopaedic partners."

The simplest way to analyze how we are doing is to compare the total amount we raise (including cash and deferred gifts, as well as money for OREF and for our orthopaedic partners), to our total expenses (which includes our general operating expenses and our specific fundraising expenses). The numbers for 2006 were as follows:

<u>Total</u> support was \$16,565,000 <u>Total</u> expenses were \$3,138,000 (18.9% of total support)

The chart below shows the comparison of our total support as defined above and our total expenses as defined above for the past several years.



OTA/OREF GIVING PARTNERSHIP

Don't forget the special OTA effort to increase funding for current research. Together with OREF, OTA has stressed designated annual giving which benefits both groups. Our goal is to encourage Order of Merit gifts contributions that total \$1,000 or more to our annual campaign. You can do so easily by going to <u>www.oref.org/ota</u>. There you can make your Order of Merit level gift, or a smaller gift if you choose. Although OREF has allowed OTA members to split gifts of less than \$1,000 between the two groups, we encourage you to donate at the \$1,000 Order of Merit level.

In a limited test period last fall – October through December – This effort led to 99 Order of Merit gifts (an increase of 42 over the previous year) resulting in \$51,000 of new funding for OTA research grants and multi-center studies.

The OTA and AAOS are working together to provide orthopaedic trauma peer-reviewed patient health care to the AAOS YOC (Your Orthopaedic Connection). Look on the AAOS website to preview the wealth of knowledge available. The OTA YOC Task Force agreed on the following action plan for updating and developing trauma content on the YOC website.

A goal was set for each Task Force member to produce one article for the YOC website by May 1st. Another suggestion from the meeting for generating new trauma topics is to review the trauma related topics in JAAOS, as well as trauma related ICLs.

Jane Baque, Senior Manager, AAOS Publication Websites, volunteered to research trauma related JAAOS articles and ICLs. In addition, Jane reviewed general history as well as future plans for the YOC website Future plans for YOC include conducting a usability study, making the site more visually interesting, updating existing content, and adding new content.

<u>OTA Classification Database and Outcomes Committee</u> Larry Marsh MD, Chair

This old Coding, Classification and Outcomes Committee has now been split into two new committees. This committee will be responsible for the OTA relevant issues contained within the committee title.

The revision of the OTA Fracture Classification will be published by Lippincott Willliams & Wilkins as a compendium in a supplement to the Journal of Orthopedic Trauma. The committee is currently working with the publisher on drawings and format. The publication is anticipated to coincide with the annual meeting in the fall. The overall alpha numeric code of the revised classification will be unified with the AO-CTF group (since 1996 there have been two slightly different versions of the code) furthering the goal of an international language to classify fractures. There will be modest changes to the current code to be more logical and to simplify complex areas that provided little value. Substantive changes have been made to the foot and dislocations and the metacarpals and phalanges will now be exactly analogous with the same areas in the foot. An introductory chapter will review progress and new information on fracture classification since the previous publication of the OTA classification in 1996. The committee is grateful to the members who provided input into the revision process.

The committee has started to assess new two new initiatives. One will be to develop a new classification for open fractures. This project will be accomplished through a combined OTA and AO-CTF task force. The other project will be to determine age adjusted normative data for fracture outcomes using the sMFA health status measure. An initial pilot is in the planning stages.

<u>Fellowship Committee</u> Lisa K. Cannada, MD, Chair

The discussion of an official match is the current hot topic. Last year, all fellowship applicants were encouraged to use the online application process and it was a success. There were 51 applicants who used the web site. A concern voiced by the applicants was the pressure to respond to offers before individuals had a chance to complete all of their interviews. *As a result, we are asking that positions are not offered until Monday, October 22nd after the OTA meeting in Boston, MA*. Currently there are 45 fellowship programs offering 78 slots for 2009 – 2010. Open fellowship positions for 2007-2008 and 2008-2009 have also been posted on the OTA web site.

This year the fellowship committee will be involved with a job fair. The OTA's second annual job fair will coincide with the 2007 Annual Meeting in Boston this October. Feedback from participants in the first annual job fair in Phoenix was positive. Currently the committee is working on guidelines for fellowship and planning the job fair at the annual meeting.

OTA MENTORING PROGRAMS Lisa K. Cannada, MD



Did you know the OTA has 2 mentoring programs? Continue reading to find out more and let's get more of you involved.

Clinical/Career Mentor Program

The goal of the OTA Mentoring Program is to provide career guidance to OTA members who are within 10 years of completing training.
