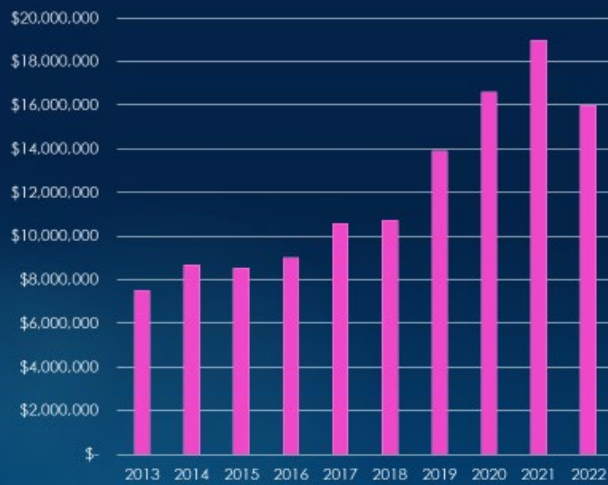

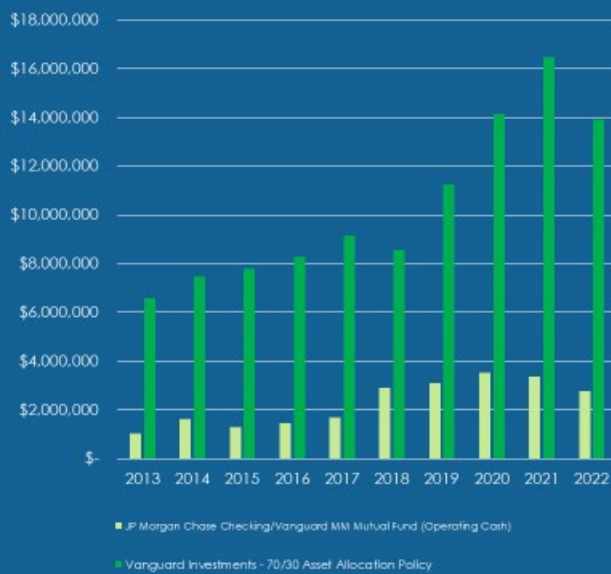

Historically strong Investment returns & funding from Operations

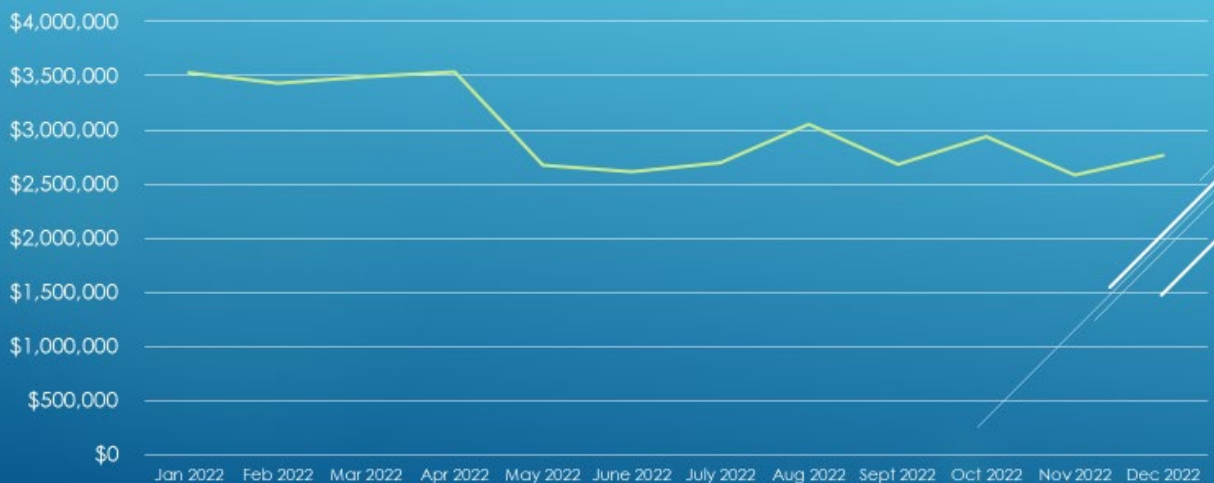
2022 turbulent year for the stock market. Expectation is that markets will slowly start to stabilize in 2023.

**Motion:** A motion was made and passed to approve the slate as presented by the 2022-2023 Nominating Committee.

**Bylaws Committee Update**

Dr. Thomas DeCoster, MD, OTA Bylaws Committee Chair presented the following proposed bylaws amendment recommendation. He noted the motivation for the amendment included the following:

- Currently the Membership Committee Chair serves a term of 1 or 2 years (compared to the chair of appointed committees who may serve from 3 – 6 years).
- The Membership Committee requires considerable knowledge of the Bylaws, Rules and Regulations regarding Membership Categories and application process and review. Frequent turnover (every year or two) in the Chair position often makes for difficult transitions.
- The proposed amendment will allow a term of 3 years as Chair, and expand the pool of possible Chairs to include all of the elected members of the membership committee.

### Section III. Membership Committee (CURRENT)

The Membership Committee shall consist of five (5) Statutory Members of the Corporation, each of whom shall serve for a single term of three (3) years. Terms on the Membership Committee will be staggered. Two (2) committee members will be elected each year at the annual meeting; except every third year only one Membership Committee member will be elected. Chair of the Membership Committee shall be appointed from among its elected members by the Board of Directors. **The Chair of the Membership Committee may serve a one or a two-year term as decided by the Board of Directors.**

### Section III. Membership Committee (REVISED)

The Membership Committee shall consist of five (5) Statutory Members of the Corporation, four (4) regular members and a Chair. A regular member term shall be three (3) years. The Nominating Committee will nominate Statutory Members to fill expiring terms. New Committee members will be elected each year at the Annual Business Meeting for each expiring term. Members may only serve one term on the Membership Committee in their lifetime.

The Chair of the Membership Committee shall be appointed from among its elected members by the Board of Directors. The Chair term shall be three (3) years. If appointed as Chair, that individual shall serve up to two (2) additional years on the Membership Committee following appointment in order to complete one (1) full 3-year term as Chair.

**Motion:** A motion was made and passed to accept the Bylaws revision.
