Thanks to the Foundation for Orthopaedic Trauma (**FOT**) the **cost of registration for the incoming fellows to attend the Annual Meeting is complimentary**. To be clear, this is only for the Annual Meeting registration fee; it does not include any pre-meeting courses, hotel, or flight expenses. On Thursday, October 16, there will be a luncheon specifically geared to the incoming fellows, formal invites will be forthcoming. We encourage you to attend, it is a chance to meet seasoned OTA faculty and address topics that are relevant during your fellowship year.

- Follow the step-by-step instructions to complete the registration process.
- Please note, the comp code will **only** work for Annual Meeting registration, it does not include the gold package (recorded content) or any pre-meeting events.
- When you get to 'Review / Check Out page, that is where you will enter the comp code.
- You may be asked to provide a confirmation letter stating that you are in fact a current fellow. The PDF version of the correspondence is attached and you can upload the letter confirming fellowship status.
- If you have already registered and paid for the Annual Meeting, please email [oconnell@ota.org](mailto:connell@ota.org) and a reimbursement can be issued.

## Case Logs – **Access starts on August 1, 2025**

All fellows are required to keep a log of their cases during their fellowship year. You must keep a case log for your program to maintain OTA fellowship accreditation status. Accurate case reporting is critical to our ability to evaluate fellowship case volumes and case types across the country. We use this information in conjunction with forthcoming survey questions to better understand the range of fellowship experiences and to inform future fellows about programs.

When you are logging your cases enter the codes as if you were billing the case. This is a good opportunity for you to better understand how to code for your own cases when you start practice. If you have questions about which codes are appropriate check in with your faculty.

Please communicate with OTA if you are having any problems entering your cases. Additionally, we urge you to communicate any CPT codes that are missing from the OTA database.

You will need to log in to the Case Log System through the [OTA Website](#) (click on the My Account Login button on the top right side), if you have any problems with your log in, contact [oconnell@ota.org](mailto:connell@ota.org) or

[ota@ota.org](mailto:ota@ota.org). Once you have logged into your profile, you will see a menu of options, select case logs. From there, another menu will appear and then you should select case log reporting. All this information is also found on the [Current Fellows](#) page of the [OTA Website](#).

#### Important Reminders:

- Please update the case log regularly. We recommend at least weekly.
- Do not enter patient identifying data such as name or complete medical record number
- ONLY record the cases where you are the **primary surgeon or first assistant**

***If you are a fellow in an ACGME accredited program, you must use the ACGME case log system. Reporting must be completed by the end of the academic year, with case log submissions due to OTA by July 31<sup>st</sup>, 2026.***
